Images: The Parent/Guardian agrees that all images may not be visually altered in any way. This includes but is not limited to color manipulation, cropping, the addition of content, or filters.

Delivery: The Photographer will make all purchased images available to the Parent/Guardian no later than seven (7) days after the Photographer has received payment in full. The Photographer will continue to make the purchased images available to the Parent/Guardian for a period of exactly fourteen (14) consecutive days following their initial delivery to the Parent/Guardian.

Read this Agreement completely and carefully. You hereby represent that you are the Parent/Guardian of Model and are authorized to execute this Agreement as the Parent/Guardian of Model. You are agreeing to let your minor child engage in the Session. By signing this Agreement you are giving up your child's right and your right and the rights of each of your and your child's personal representatives and assigns, to recover from the Photographer, and his or her successors and assigns, and, if applicable, owners and lessors of any premises used for the Session, in a lawsuit for any personal injury to your child or any property damage that results from the risks that are a natural part of the Session.
